Mark D. Hoy – is an Investigations Supervisor with the Ohio Department of Public Safety-Bureau of Motor Vehicles Investigations Mr. Hoy has served since 2003 as a college intern, Investigator, Investigations Chief and Investigations Supervisor. Mr. Hoy has a Bachelor of Criminal Justice Degree from Tiffin University and core criminal justice studies at the University of Toledo, Currently Mr. Hoy actively maintains his peace officer commission and is actively engaged in the development and maintenance of BMV Investigations Case Management Systems, Fraudulent Document Instruction committee and others. As a certified instructor instructing at the Ohio Peace Officer Training Academy- London since 2005, Mr. Hoy has also provided numerous trainings to various law enforcement agencies, civic groups and ODPS/BMV personnel. Training sessions conducted have included dimensions such as fraudulent document identification, identity fraud, dealer licensing investigations, internal employee investigations, LEADS, and electronic investigative tools.

Jennifer Johnson - Is currently a licensed Independent Social Worker Supervisor. Ms. Johnson graduated from Olivet Nazarene University in 2006 with a Bachelor of Social Work and Case Western Reserve University in 2007 with a Master's of Science in Social Administration. Ms. Johnson is currently the Executive Director for the Canopy Child Advocacy Center in Cleveland. Ms. Johnson is responsible for the overall operation of the facility to include general administration, financial and personnel management, program development, policies and procedures development and community relations. Ms. Johnson will present on how their agency assists in child abuse cases by using a multidisciplinary approach to victim advocacy, mental health, prosecution, medical, law enforcement, child protection and other allied community resources.

Phil Chalmers – Phil Chalmers is a true crime writer, television personality, and a homicide trainer, who has interviewed hundreds of teen killers, school shooters, mass murderers and serial killers. He has been studying killers and culture for 35 years. He is the author of several books including the popular Inside the Mind of a Teen Killer. Interviewing as many subjects as possible, with the goal of profiling teen killers and school shooters Mr. Chalmers came up with the causes, warning signs and triggers of teen killers and school shooters. Phil's live trainings contain hundreds of crime scene photos and active shooting videos. Attendees will get the rare opportunity to interview a serial killer or school shooter live on the phone, allowing them to ask questions they always wanted to ask of these violent offenders. Subjects covered are very popular among law enforcement. School administrators, counselors and probation officers.

Julie Richards - is a Licensed Social Worker and a Licensed Professional Clinical Counselor with over 25 years of experience in the mental health and social services fields. She has worked with children, teenagers, adults and families from all different socio-economic backgrounds in both urban and rural locations. Julie has worked in a variety of settings including a private mental health counseling practice in Tiffin, agencies in Dayton, Akron and Columbus as an adoption assessor; Employee Assistance Programs in Toledo and Southeast Michigan where she provided brief, solution-focused counseling; and in Higher Education where she worked as the Director of Counseling and the Director of Safety and Security. Currently, Julie works at NAMI Northwest in Fremont where she supports the mission to educate, advocate and support individuals and their family members living with mental illness. Julie provides trauma informed care to those she serves and is trained in EMDR (Eye Movement Desensitization and Reprocessing) treatment. She is also trained in crisis intervention and is available to provide EMDR to first responders. Julie uses a variety of other treatment modalities including CBT (Cognitive Behavioral Therapy), Prolonged Exposure Therapy, and Suicide Prevention Interventions. Ms. Richards presentation will cover child and adolescent brain development, ACES

Timothy Wise - Has a masters in counseling and is licensed through the State of Ohio as a Professional Clinical Counselor with a Supervisor Endorsement. Mr. Wise's published works include 'Stopping the Runaway 2005" and "To Right Yesterday 2007". Mr. Wise will cover Mental Illness signs, symptoms and triggers for kids, medications differences, risk assessments and suicide/self-injurious behavior.

Jared Watson - Graduated from Columbian High School in 1997. Jared earned a degree in police science and completed the police academy at Terra Community College in 2003. He started his law enforcement career with the Republic Police Department. In 2004, he accepted a position with the Cedar Point Police Department. In 2005, Jared returned to his hometown, accepting a position with the Tiffin Police Department. Jared was promoted to Sergeant with the department in 2013. During his time with the Tiffin Police Department, Jared had the opportunity to create and maintain several community engagement groups, including block watches and a citizen's police academy. He is currently the commander of the crisis negotiation team, overseeing numerous critical incidents. Jared was certified in CIT early in his career and has continued to work with the program throughout the years. Mr. Watson's presentation will cover CIT skills.
